RESOLUTION 2010-76 Water Rates

Councilman Dash moved and Supervisor Pordum seconded,

WHEREAS: The Town of Evans has not raised water rates in the Town since 2006,
and

WHEREAS: The Erie County Water Authority has increased the bulk purchase price of water to the Town of Evans by: \$0.11 per 1,000 gallons in 2007, \$0.05 per 1,000 gallons in 2008, and \$0.10 per 1,000 gallons in 2010, and

WHEREAS: The Town of Evans water fund has absorbed past water rate increases through improved efficiencies, and

WHEREAS: The January 1, 2010 increase by the Erie County Water Authority cannot be absorbed without creating a deficit in the water fund, now therefore be it

RESOLVED: That pursuant to Section 106-1, the price of water be \$5.05 per 1,000 gallons for Town water customers and \$5.80 per 1,000 gallons for out of district customers, and be it further

RESOLVED: That these rates will go into effect as follows for the established billing districts:

District #2, effective March 1, 2010
District #3, effective April 1, 2010
District #1, effective May 1, 2010

WHEREAS, the Town of Evans received funding assistance from the Erie County Community Development Block Grant program for the upcoming year (2010-2011) to conduct a comprehensive neighborhood revitalization strategy for restoring the Lake Erie Beach community into an attractive and vibrant neighborhood within the Town of Evans;

WHEREAS, the proposed strategy will identify issues and concerns; define neighborhood boundaries; land use; neighborhood demographics; assessment of economic need; housing characteristics; create strategies and performance measures

and identify key resources (existing programs, funding opportunities & strategic partners);

WHEREAS, the Town published a Request for Proposal requesting proposals from professional consulting firms to conduct a Neighborhood Revitalization & Comprehensive Housing Strategy for the Lake Erie Beach Neighborhood;

WHEREAS, the Town received four (4) proposals for consideration;

WHEREAS, the project selection team, made up of County and Town stakeholders, selected the proposal submitted by Peter J. Smith & Company, Inc. based on the firm's reputation, credentials; experience and project fee;

NOW THEREFORE, BE IT RESOLVED, that the Town Board authorizes Supervisor Francis J. Pordum and/or appropriate Town Officials to sign, submit and execute a contract with Peter J. Smith & Company, Inc. for conducting a comprehensive neighborhood revitalization strategy pursuant to the approval of the Town Attorney and Director of Finance.

RESOLUTION 2010-80 Supporting the NYSDEC Household Hazardous Waste State Assistance Program

Councilman Cooper moved and Supervisor Pordum seconded,

WHEREAS, the Town of Evans, acknowledges its responsibility to keep our communities safe, clean and healthy, and

WHEREAS, household generated hazardous waste is a dangerous and problematic waste stream which increases the risk from fire and poisonings if improperly stored, and

WHEREAS, improper disposal of household hazardous waste can pollute our environment, pose a risk to sanitation workers, and impact wildlife, and

WHEREAS, the safe recycling and/or disposal of household generated hazardous waste is a priority for County residents and their elected officials, and

WHEREAS, the New York State Department of Environmental Conservation is authorized by section 54-0705 of the Environmental Conservation Law, and the 6NYCRR subpart 373-4 Regulations, to enter into contracts on behalf of the State to provide grants to reimburse 50% of expenses to municipalities for Household Hazardous Waste Programs, and

WHEREAS, the Town of Evans has, through the Northeast Southtowns Solid Waste Management Board (NEST), worked with the Erie County Department of Environment and Planning to host an annual collection event to reduce risks, protect the environment and insure proper disposal of household hazardous waste materials, and

WHEREAS, THE Town of Evans, NEST, has not a received commitment from New York State to reimburse expenses for the application submitted for 2010 program expenses, and

WHEREAS, the Town of Evans, NEST has not received a grant from New York State to reimburse the Town of Evans, NEST for 50% of the costs generated by a collection event which would be held in 2010, and

WHEREAS, and there is great concern about the sustainability of the Household Hazardous Waste Collection Program and its ability to continue to offer this important service to residents of Erie County without the fiscal assistance from New York State.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Evans does hereby urge New York State Governor David Paterson to release funds necessary to fulfill reimbursement expectations of municipalities which, in good faith, plan to provide Household Hazardous Waste Collection opportunities to residents in 2010, and

BE IT RESOLVED, that New York State Governor Patterson, is encouraged to continue support and fund this important reimbursement program in 2010 and beyond to protect our residents and our environment, and,

FURTHER RESOLVED, that the Town Clerk of the Town of Evans shall forward copies of this resolution to Governor David Patterson, New York State Comptroller's Office, Senate Majority Leader Pedro Espada, Jr., Senate Minority Leader Dean G. Skelos, Assembly Speaker Sheldon Silver, Assembly Majority Leader Ron Canestrari, Assembly Minority Leader Brian Kolb, Senator Dale Volker, and Assemblyman Jack Quinn
