The Town of Evans invites bids for the demolition without asbestos abatement, of structures on the following residential property located within the Town of Evans, New York:  
940 Sturgeon Point Road  
SBL # 205.00-1-24

The project generally consists of demolition for the complete removal and disposal of the unsafe structure(s) and foundation of said property, including work to render the properties safe, including, but not limited to fill, grading, and seeding. Sealed bids labeled "BID ENCLOSED: DEMOLITION OF 940 STURGEON POINT ROAD" will be received by the Office of the Town Clerk of the Town of Evans, 8787 Erie Road, Angola, NY 14006, during regular business hours (Monday, Tuesday, Thursday and Friday from 8:00 a.m. through 4:00 p.m. and Wednesday from 9:00 a.m. through 5:00 p.m.) until 10:00 AM (Local Time) on September 17, 2018 at which time the bids will be publicly opened and read aloud. Bids submitted by fax or email will not be accepted. A copy of the bidding documents may be obtained from or examined at the Office of the Town Clerk of the Town of Evans, 8787 Erie Road, Angola, NY 14006 after September 7, 2018.

Each bid must be accompanied by a certified check or bid bond from a domestic carrier licensed to do business in the State of New York in the amount of not less than five (5%) of the amount of the bid submitted.

Bidders will be required to comply with Code Rule 56 of the New York State Department of Labor as well as New York State prevailing wage and supplement requirements on this project.

A Statement of Non-Collusion and Performance and Payment Bonds will be required for this project. The Town of Evans is exempt from the payment of sales and compensation use taxes of the State of New York and of cities and counties on all materials, equipment, and supplies sold to the Town of Evans pursuant to the contract. The sales tax exemption is extended to the Contractor, Subcontractors, and their suppliers.

All bids shall be binding for a period of forty-five (45) days after the bid opening date. The Town of Evans reserves the right to reject any and all bids, for any reason whatsoever and to waive any informalities in any bid.




