RESOLUTION 2019 #69 Adopt Joint Comprehensive Plan

Councilman Schraft moved and Councilman Macko seconded,

WHEREAS, the Town Board of the Town of Evans (the "Board") is responsible for the preparation and adoption of the Town of Evans-Village of Angola Comprehensive Plan (the "Plan"), pursuant to Section 272-a of the New York State Town Law; and

WHEREAS, the Plan was funded by Erie County through the Community Development Block Grant program; and

WHEREAS, a steering committee (the "Committee") of volunteers, including Town and Village residents, elected officials, local Board members, and other representative stakeholders was created and charged with the update to the Plan together with the planning consultant, Clark Patterson Lee; and

WHEREAS, numerous committee meetings, public meetings and workshops, and other avenues for community outreach were held through the duration of the project to receive public input on the update to the Plan; and

WHEREAS, the Committee and the planning consultant undertook a comprehensive study of the historic and existing conditions in the Town and Village; identified issues and opportunities; analyzed numerous topics and potential options; and developed goals, objectives, policy recommendations and implementation strategies which resulted in the Comprehensive Plan Update; and

WHEREAS, the Committee provided the Board with the final draft of the Plan prior to the regular Board meeting on November 7, 2019 for review and consideration of adoption pending a public hearing; and

WHEREAS, on August 31, 2019 the Board referred the Plan to Erie County Department of Planning under Section 239m of the General Municipal Law; and

WHEREAS, Erie County Department of Planning reviewed the Plan and provided minor comments including the addition of other County-level plans that are pertinent for reference in the Plan and general comments on future infrastructure and implementation, which were incorporated accordingly into the Plan; and

WHEREAS, pursuant to Section 272-a.6 of Town Law of the State of New York, the Board did hold public hearings on August 15, 2019 and December 5, 2019 at Town Hall to provide an opportunity for citizen comment prior to final adoption; and

WHEREAS, the Board, as the designated Lead Agency, conducted an environmental review under the State Environmental Quality Review Act and issued a Negative Declaration on December 19, 2019.

WHEREAS, the Town Board, after having reviewed the comprehensive plan further and considering public comment from the above referenced public hearings, made modifications to certain portions of the comprehensive plan, specifically the future land use map of the Town, based upon the following justification:

Recent trends in land use show towns are moving away from Light Industrial (even though our future land use map increased in size). With this comprehensive plan, the Town of Evans must look at trends to best move the Town forward to create a sound tax base and employment. There are many towns and cities with streets lined with empty commercial buildings that need to be repurposed. The Town of Evans has empty buildings on Hardpan Road that need to be rejuvenated as they generate the greatest tax base from our industrial zone as these properties are in the Lake Shore Central School District. Just recently, a local manufacturing plant closed stating the trend in manufacturing is to move away from facility ownership. The Framework for Regional Growth Plan is to restrict "strip" commercial and industrial development along arterials and highways, and to minimize conversion of significant open space and agricultural lands in developing areas.

A goal of the Erie County Farm Protection Plan-2012 is establishing an Agribusiness in the Town that will stimulate economic growth. The Town believes it is an investment to support agriculture and open space preservation that coincides with Goal #4 of the Town's Comprehensive Plan. The former airport site was found to be the best location because of the direct support of local farmers which allows for "direct from the farm" products. The primary agriculture on Eden Evans Center Road directly supports the initiative of the project by retaining the best farmland in Town. The lands are in the Erie County Agricultural district and creates a good buffer between industry and residential along with protecting larger lot sizes. With cooperation between the new Agribusiness and local farmers, tourism to our Town can be increased by implementing Agritourism through the "Sowing the Seeds for Southtowns

Agribusiness” Plan, which enables people to see how their food is grown and prepared, using local crops, from start to finish.

Categorizing the south side of Eden Evans Center Road as Ag-Industrial mimics the uses of the Agricultural and Open Space zoning but draws more attention to the commercial aspects of the zone. It protects the lands, allows future agriculture development, and directly supports the development of the new Agribusiness to ensure its success.

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Evans does hereby adopt and place on file the update to the Comprehensive Plan, as an important planning tool for the future of the community which identifies a wide range of issues, initiatives, studies, projects and programs which can be undertaken by various entities in the short- and long-term.

NOTICE IS HEREBY GIVEN that the Tax Roll and warrant for the County and Town taxes for the Town of Evans, for the year 2019 have been received by me on January 5, 2019 and that all persons and corporations named therein are required to pay their taxes at my office at the Evans Town Hall, 8787 Erie

Road, Angola New York, on or before the 15th day of February 2019 and when so paid shall be received with no additions or penalties. Penalties will be added after that date pursuant to Chapter 812 of the Laws of 1942 as amended. On all taxes paid between February 16th and February 28th 1.5% shall be added. If paid between March 1st and March 15th, 3% shall be added; if paid between March 16th and April 1st, 4.5% shall be added; if paid between April 2nd and April 15th, 6% shall be added; if paid between April 16th and April 30th, 7.5% shall be added. On all taxes paid on May 1st, 2019 the 7.5% penalty fee is added to the levy, forming the base of the tax then due. Thereafter, interest is added to the base at the rate of 1.5% per month on the 1st of each month. Unpaid taxes will be returned to the Erie County Commissioner of Finance on July 3, 2019.

Such bills can be paid by check, money order or draft through the mail or cash, check, money order, MasterCard, Visa, Discover or American Express (convenience fees apply) may be paid at the office of the Evans Town Clerk, Evans Town Hall,

8787 Erie Road, Angola, New York, 14006.


